For over 30 years, Sexual Assault Prevention and Response Services has been providing prevention and intervention services in the Tri-County region to those who have been impacted by sexual violence.

The Children's Advocacy Center is one of the many programs of the Sexual Assault Prevention & Response Services and is a multi-disciplinary collaborative response to allegations of child abuse within our region of Maine—Androscoggin, Franklin & Oxford Counties as well as the towns of Bridgton and Harrison.

1 in 5 Mainers will experience sexual assault at some point in their lifetime.

Approximately 50% of calls to the Maine's sexual assault crisis helpline are related to child sexual abuse.

SAPARS serves over 1,200 people and more than 4,000 hours of service each year. Of those numbers, the CAC serves over 300 unduplicated children and their non-offending care providers annually, which is only responding to those children who have the courage to speak their truth and does not begin to identify & support those children who have not reported their abuse for many complex and diverse reasons. **The community needs to know you stand with them and for them by supporting this outreach & fundraising event.**
